



ENGINE LIMITED WARRANTY

PG Enterprises, LLC d/b/a Petty's Garage ("PG") warrants to the original purchaser of the engine that a PG high performance Long Block engine shall be free of defects from workmanship until the earlier of two years or 30,000 miles, and a PG high performance Short Block engine shall be free of defects from workmanship until the earlier of 12 months or 12,000 miles when: 1) installed properly by a competent technician, 2) used for normal street operation, and 3) serviced at proper intervals.

PG, under this Limited Warranty, will provide all repair, labor, inspection, machining, assembly and parts at no cost to the original purchaser. This warranty only covers the engine itself, at no time does this warranty or any other warranty given by PG cover the labor costs to remove or replace the engine from a vehicle nor does it pay the labor costs of any non-PG mechanic. No exceptions.

EXCLUSIONS and LIMITATIONS:

This warranty does NOT cover damage or loss due to the following:

1. Any product used for racing (track, street or otherwise) or other competition.
2. Misuse, maintenance neglect, abuse, vandalism, abnormal operation or accidents, not changing oil on time or not enough oil.
3. Defective or improper installation / tuning (e.g. Engine not installed properly by the purchaser, a distributor or a third-party) which results in damage / destruction to Crankshaft, Connecting rods, Pistons, Piston Rings, Camshaft, bearings, valve train components, seals and/or any other components).
4. Damage resulting from low fuel pressure due to insufficient fuel pump system and/or electrical system voltage.
5. Damage resulting from pre-ignition / detonation, incorrect installation of any timing components, excessive timing (Tuning), bad fuel / incorrect fuel octane rating, incorrect fuel type indicated by calibration parameters (e85, Race Fuel etc.) including but not limited to melted or broken piston, broken piston rings, damaged cylinder heads, leaking head gaskets, etc.
6. Improper break in: premature wear to Crankshaft, Pistons, Camshaft and associated bearings resulting in damage to these components or other components.
7. Environmental conditions, overheating, or freeze cracks: warped heads or cracks in head or block. Removal of the overheat telltales installed by PG will void this warranty.
8. Damage resulting from excessive RPM such as broken crankshaft, broken connecting rods, broken or damaged piston / piston rings or broken valve train components.
9. Foreign material in combustion chamber or oil pan, such as bolts or nuts dropped into cylinders destroying pistons and valves or other components.
10. Repair or replacement of any accessory or service item, including specifically but not limited to: all components of the cooling, fuel, electrical, and ignition systems including belts, hoses, and filters.
11. Replacement of any aftermarket part used in the engine. PG is not responsible for defective parts supplied by aftermarket companies that may have been used in the build process such as but not limited to: Distributors, Ignition Coils, Sparkplugs, Carburetors, Fuel Injectors, Lifters/Valve Train Components, Water Pumps, Fuel Pumps, and Oil Pumps etc. Most of the parts will carry a

12. warranty through their respective manufacturer or supplier. When an engine is purchased with the optional Engine Dyno Tuning service, PG might be able to detect and diagnose a defective part and will change it out until the problem no longer occurs. This will not ensure a part is not defective and premature failure can still arise after the engine has left our facility
13. Compliance with emissions/pollution requirements is the sole responsibility of the Purchaser/Vehicle Owner and is not part of this warranty, and failure to do so is not covered.
14. Failure of components or parts not furnished or otherwise approved by PG for installation, or components or parts unsuitable for use with engine.
15. Crankshaft thrust surface wear and any associated damage due to defective or improperly installed clutch, flywheel, torque converter flexplate or other powertrain components.
16. Non-PG modifications or disassembly- any disassembly of the engine or any modification to the engine will void this warranty.
17. Nitrous Oxide or Supercharger- installing these components on an engine that is not expressly built for such will result in a void in warranty. Consult the PG Tech line if unsure.
18. Over-fueling or other dilution of lubrication due to carburation / fuel injection calibration (e.g via non-PG Tuning).

THIS WARRANTY DOES NOT COVER OR PROVIDE PAYMENT OR REIMBURSEMENT FOR THE FOLLOWING SERVICES:

1. Replacement of oil, anti-freeze, or any other substance
2. Towing charges, transportation charges, vehicle rental, or other substitute transportation
3. Diagnostic time, labor to remove and/or reinstall engine, or service calls
4. Transportation or lodging
5. Loss of time, income, sales or profits, loss of use of vehicle
6. Lift, dock, or storage fees
7. Tune-ups or replacement of belts, hoses or maintenance items, routine, regularly required maintenance
8. Injury or death to persons or damage or destruction of property; consequential or incidental damages
9. Shipping warranted engine to and from PG
10. Any other incidental or consequential damages.

CLAIM PROCEDURE:

Immediately after the discovery of a potential defect the customer must comply with the following procedure:

1. Discontinue the use of the engine
2. Do not pull engine out of vehicle
3. Contact PG
4. Let PG help you figure out what is wrong with the engine (a substantial portion of all issues can be fixed with the help of the PG tech while the engine is still in the vehicle).
5. Unless a field repair is specifically authorized by PG, the engine in its entirety – with oil pan and valve covers as installed -- thought to be defective must be returned to PG for evaluation. A copy of the customer's original invoice or receipt must accompany all returned engines or parts.
6. Returned engines must be returned with all parts intact that were originally furnished with the engine or charges will be made for the missing parts.
7. Disassembly of the engine by **any parties other than PG** will void the warranty unless it is specifically authorized by PG.

BY PURCHASING THIS ENGINE FROM PG IT IS UNDERSTOOD THAT THE CUSTOMER ACCEPTS AND AGREES TO COMPLY WITH THE TERMS OF THE WARRANTY.

A SIGNED COPY OF THE WARRANTY CARD MUST BE RETURNED WITHIN TEN DAYS OF RECEIVING THE ENGINE. FAILURE TO DO SO WILL VOID ANY AND ALL WARRANTIES.

MISCELLANEOUS: NEITHER RESELLER NOR ITS EMPLOYEE, OR ANY EMPLOYEE OF PG IS AUTHORIZED TO MAKE ANY MODIFICATION, EXTENSION, OR ADDITION TO THIS WARRANTY. PG RESERVES THE RIGHT TO MODIFY THIS LIMITED WARRANTY AT ANY TIME; HOWEVER, ANY SUCH MODIFICATION WILL NOT ALTER THE WARRANTY CONDITIONS APPLICABLE AT THE TIME OF SALE.

CONSUMER PROTECTION LAWS. This warranty is valid only in the United States and Canada. Some states and provinces do not allow the exclusion or limitation of certain damages or the duration of implied warranties or conditions so the above limitations or exclusions may not apply to you. This warranty gives you specific legal rights, and you may also have other rights that vary by state or province. The laws of the State of North Carolina will govern this warranty. The U.N. Convention for the International Sales of Goods will not apply. Any action brought to enforce or interpret this warranty shall occur only in a court of the State of North Carolina or in U.S. District Court for the Middle District of North Carolina.
